

## I. HOW TO CREATE A MYCIC ACCOUNT

2. Register for the account. Decide which option you would like to take. Both options will lead you to the same account.

- viii. Read the Terms and Conditions. Click I Accept. ix. Enter your information and follow the steps to create your account.


